Freedom of Information Act 2000

I am writing in response to your request for information made under the Freedom of Information Act 2000 in relation to hernia repairs using mesh implants.

You asked:

- 1. Can any of your Hospital Trust Surgeons repair Hernias without using Mesh implants? If so, how many of these surgeries are performed per year?
- 2. Can any of your Hospital Trust Surgeons remove Hernia Mesh without causing complications? If so, how many of these surgeries are performed per year?
- 3. Do any of your Hospital Trust Surgeons repair without using Mesh Implants in the following areas? Please could you specify which Surgeon specialises in each of the following areas? And if so how many are performed per year?
- 4. Can any of the Surgeons remove Mesh that is causing complications from the following areas? Again, can you please specify which Surgeon performs this surgery, and how many are performed per year?

The Trust asked for clarification on the following point: *Do you mean prolapse rather than hernia.* As we have not heard of a womb / bladder / vagina hernia and we do not want to give inaccurate information.

You provided the following clarification: Yes, Prolapse and or SUI repairs for that section of the request.

Please note: We are unable to tell whether or not mesh was used in the above procedures. These figures are based on primary procedures between April 2016 and December 2018.
