- 4. Please can you give me a breakdown of permanent or fixed term doctor vacancies across the Trust? Please break down by specialty and grade.
- 5. Can you please advise of any doctor vacancies that have been vacant for 6 months or more?
- 6. In the last 12 months, how much has the Trust paid in introductory fees to recruitment agencies for recruiting doctors on a permanent or fixed term basis? Please break down by specialist and grade.
- 7. Which agencies has the Trust engaged with in the last 12 months for permanent or fixed term recruitment of doctors?
