I am writing in response to your request for information made under the Freedom of Information Act 2000 in relation to serious untoward incidents reported within the Trust during 2016.

1. The number all Serious Untoward Incidents (SUIs) reported within your NHS trust which occurred during 2016 (Jan-Dec), and the details of what occurred.

Please see the tables overleaf for details of the incidents reported in the 12 months, January to December 2016.

2. Of those SUIs, how many resulted in a patient death.

Although we can confirm that out of the Serious incidents reported 14 patient's subsequently died these would be multifactorial and therefore in appropriate to ascertain whether they died as a direct result of the incident.
