Freedom of Information Act 2000

I am writing in response to your request for information made under the Freedom of Information Act 2000 in relation to Elective waiting list and discharge to care homes.

You asked:

- 1. What is the current size of your Elective wait list broken down by specialty in May?
- 2. How many patients from your hospital were discharged to home care settings, i.e. residential care homes/nursing homes etc. in the last 6 months (December May)?

Trust response:

The first table is May's elective Waiting List as a snapshot from 1st June. The second table includes patient discharges to home care settings.

There is a slight caveat to the information provided which applies only to those being discharged to their usual place of residence which may in fact be a care home.

Patients living in residential care homes have been determined by use of a table which lists all the local care homes.

Because the address given by the patient cannot be relied on to exactly match the address listed on the reference dataset, we need to rely on matching postcode.

This means that we risk including patients who do not live in the care home, but share a postcode. Whilst larger care homes may have their own postcode, smaller ones will often not, and their neighbours will end up being counted as well. We have tried to limit this by excluding patients under 70, but whilst this will reduce the false positives, it will also incorrectly exclude

younger care home residents. An attempt to quantify this a few years ago led to an estimate of around 10% false positives

This method will also miss anyone who lives in a care home not on the list, anyone who gives us the wrong postcode, and anyone who still has their original address on our system. We have no way of quantifying this.
