## Freedom of Information Act 2000

I am writing in response to your request for information made under the Freedom of Information Act 2000 in relation to STP jobs, workforce and spend.

You asked:

- 1. The number of jobs created/seconded to work as part of the STP/ICS. Please categorise these by salary band and job title and whether they were created/seconded from other parts of the NHS.
- 2. The amount spent on external consultancy as part of the STP/ICS. Please break these down by individual contracts with a summary of the purpose of the contract and the company used.
- 3. The amount of capital/transformation funding identified as required in the original STP plan and the amount of capital/transformation funding received to date or anticipated.
- 4. The workforce projections for the STP/ICS broken down by broad job roles i.e. doctors, nurses etc. Please also provide current figures.
- 5. The total number of acute beds and community beds projected as necessary for the STP/ICS and the current figures.
- 6. The original financial projections of the gap, when the STP was drawn up, (if there is a gap) between income and expenditure in the area and the latest projections. Please provide these for the years you have available.

2. The Kent and Medway Sustainability and Transformation Partnership (STP) uses external support where we do not have the skills, expertise, experience or capacity in-house or are unable to free up resources from our partner organisations, and/or where the support needed is short-term and doesn't warrant permanent roles. We are very conscious of costs and are increasingly looking to develop our in-house capability and capacity where it would be more efficient to do so. Since October 2017, we have created roles to take forward the STP work programme and significantly cut back on our use of external support.

The STP hosts a range of transformation programmes delivering joined up working, improved patient care and greater efficiencies and productivity for the Kent and Medway system as well as the corresponding budgets. This includes programmes that pre-dated the STP, such as the Stroke and East Kent transformation programmes, which have had a significant investment. See below for a summary of the firms used, contract values and purpose of the contract for 17/18 and 18/19 to date.

3. The original STP plan published in 2016 identified a Sustainability and Transformation funding investment of £122m in 2020/21. Kent and Medway were successful in the STP Wave 3 capital funding round and were allocated £19.5m in 2017/18. To note, the transformation funding received to date does

not take into account any provider and commissioner sustainability funding (STF, PSF and CSF).

4. Workforce projections are currently being developed as part of the workforce strategy. As such, we are unable to share any workforce projections at this point.

In terms of current figures for broad healthcare job roles (total headcount as at 31 March 2018):

- GPs: 1,045
- General Practice Nurses: 694
- Consultants: 973
- Training grade doctors: 635
- Staff grade doctors: 388
- Registered Nursing, Midwifery and Health Visiting staff: 8,684

In terms of current figures for broad social care job roles (total headcount as at 31 March 2017):

- Regulated professional jobs: 1,925
- Direct care jobs: 34,700
- Care Worker jobs: 25,200

5. The original STP plan published in 2016 modelled acute bed requirements in Kent and Medway based on a number of assumptions and forecasted that the system would need around 2,600 acute beds in 2020/21 after the implementation of the STP transformation programmes (see p24 in STP plan).

We do not undertake a regular stocktake of beds across the Kent and Medway system. However, NHS England publishes data on bed availability and occupancy, which can be found here:

6. The original STP plan published in 2016 identified a predicted total system challenge of £434m in 2020/21 in a 'do nothing' scenario. We have not updated the financial projections for the STP.

However, the current 18/19 forecast for the Kent and Medway NHS organisations is for a planned (control total) deficit of £56.1m; this includes the agreed provider and commissioner sustainability funding (PSF and CSF).
