You asked:

 Does your trust have a policy covering the provision of female sanitary products (such as sanitary pads and tampons, but excluding maternity sanitary products) to in-patients? If yes, please provide this policy.
 How many premises with inpatient beds are there in your trust, and at how many of these premises are female sanitary products (such as sanitary pads and tampons, but excluding maternity sanitary products) available to purchase

on site? For example, in shops or bathroom vending-machines.

Trust response:

1. Yes sanitary towels which are stock items

2. Using the search terms: "sanitary", "tampon" and "towel" in the Organisation Wide Q-Pulse database.

• These searches retrieve no Trust-wide policy specifically on the provision of female sanitary products.

• These terms do not appear in the context of the provision of female sanitary products within any other Trust-wide policy.

3. We have 2 sites that sell sanitary products from their retail outlets (League of Friends at Maidstone Hospital & WH Smiths at Tunbridge Wells Hospital). We do not have vending machines in our public toilets.

4. As all the sanitary pads purchased by the Trust are classified as maternity pads we are unable to split the cost to show those not used for maternity.

2017/18 – As at Mar 2018 there were 716 Core General & Acute Beds open overnight across Maidstone and Tunbridge Wells NHS Trust (MTW) Hospitals + 47 Maternity Beds +5 Maternity at Crowborough (+9 private beds)
2016/17 – As at Mar 2017 there were 727 Core General & Acute Beds open overnight across MTW Hospitals +52 Maternity Beds + 5 Maternity at Crowborough (+9 private beds)

• 2015/16 – As at Mar 2016 there were 688 Core General & Acute Beds open overnight across MTW Hospitals + 52 Maternity Beds + 5 Maternity at Crowborough (+ 18 private beds)

2014/15 – As at Dec 2014 there were 635 Core General & Acute Beds open overnight across MTW Hospitals + 52 Maternity Beds (+ 13 private beds)
2013/14 – As at Mar 2014 there were 656 Core General & Acute Beds open overnight across MTW Hospitals + 52 Maternity Beds (+ 13 private beds)
2012/13 – As at Nov 2012 there were 670 Core General & Acute Beds open overnight across MTW Hospitals + 52 Maternity Beds (+ PPU at Tunbridge Wells Hospital opened in October 2012 with 26 beds as 4 of the rooms were set up for out patients.)
