- Details of the injury (i.e. moving and handling injury, slips/trips/falls and so on)
- Staff role if known (i.e. staff nurse, doctor)
- · Whether compensation was paid
- The total amount of compensation paid
- If information available, any action taking following the incident (i.e. additional training, non-slip flooring and so on)

Student nurse has injured knee when assisting a patient to the ground. non-injury assisted fall occurred by patient. Student did not mention injury/pain during this shift but has since been signed off and is awaiting MRI of knee. University occupational health and own GP dealing with injury.	N/A	REPUDI	Nil
