I am writing in response to your request for information made under the Freedom of Information Act 2000 in relation to hospital discharge.

You asked:

I'm looking for the number of people aged 65+ who were discharged between 22.00 and 06.00, for each month between January 1 2016 and December 31 2016.

I further request the information, if possible, to broken down into ages 65-74, 75-84, 85+ for the discharged patients.

Could I also have detail of how many patients were discharged to their home, to a nursing home, care home, rehabilitation, transferred etc. and whether their relatives were informed.

Trust response:

The table attached provides the information related to discharges recorded between the hours of 22:00 and 06:00. However, discharges may have occurred earlier in the day but administration processes occur later.
