Freedom of Information Act 2000

I am writing in response to your request for information made under the Freedom of Information Act 2000 in relation to Ophthalmology appointments.

You asked:

1. How many post-op Ophthalmology appointments should have taken place in the winter of 2018/19?

2. Of these how many did not take place due to "winter pressure"?

3. How many Ophthalmology appointments were missed in the year 01 April 2018 to 31 March 2019 due to patients failing to attend?

4. How many Ophthalmology appointments were missed in the year 01 April 2018 to 31 March 2019 due to mistakes that were the fault of the hospital – i.e. patients advising that they were unable to attend, but the booking not being properly cancelled?

Trust response:

Please note - We do not have information about whether the appointment was post op or not or why the appointment was cancelled so we are unable answer questions 1 & 2 without the manual checking of individual patient records. The Trust has estimated that it will cost more than the appropriate limit to consider this part of your request. The appropriate limit is specified in regulations and represents the estimated cost of one person spending 3½ working days in determining whether the Trust holds the information, locating, retrieving and extracting the information. Under Section 12 of the Freedom of Information Act 2000 the Trust is not obliged to comply with this part of your request and we will not be processing this part of your request further.

3. Shows the ophthalmology outpatient activity split into New & Follow Up Appointments.

4. Shows the number of hospital cancellations & patient cancellations.
