Freedom of Information Act 2000

I am writing in response to your request for information made under the Freedom of Information Act 2000 in relation to Zero hours contracts.

You asked:

- 1. What is your policy on zero hour's contracts?
- 2. How many workers are currently employed by Maidstone and Tunbridge Wells NHS Trust on zero hours contracts? What is the breakdown of these figures according to (a) occupation, (b) sex, (c) race and (d) age?
- 3. How many workers are currently employed on zero hours contracts via agencies, contractors or sub-contractors that provide workers to Maidstone and Tunbridge Wells NHS Trust? If this data is not available, please provide the names of the agencies, contractors or sub-contractors that you use to employ workers indirectly.
- 4. How many workers are currently employed on minimum hours contracts directly by Maidstone and Tunbridge Wells NHS Trust or via agencies, contractors or sub-contractors that provide workers to Maidstone and Tunbridge Wells NHS Trust?
- 5. How many workers in total does Maidstone and Tunbridge Wells NHS Trust currently employ? What is the breakdown of these figures according to (a) occupation, (b) sex, (c) race and (d) age?

Trust response:

- 1. We do not have a policy on zero hour's contracts. However, we do have an "in-house bank". People are invited to join the bank and there is no mutuality of obligation. This means that the Trust does not have to offer work and the bank worker does not have to accept any offer of work.

- 3. We currently use approx. 300 agency supplied staff across the Trust but their contract sits with their agencies
- 4. The requestor has defined this as part-time contracts, we have 2,210 individuals on part-time contracts
