Freedom of Information Act 2000

I am writing in response to your request for information made under the Freedom of Information Act 2000 in relation to removals from waiting list for reason "died".

You asked:

For each of the separate periods (1) 2017-18, (2) 2018-19, (3) 2019-20, (4) 2020-21, and (5) April-August 2021, please provide:

1. The number of pathways on the trust's elective waiting list(s) at the beginning of the period (also known as incomplete pathways).

2. The number of times during the period a pathway (person/instance) has been removed from that/those lists

3. A breakdown of the number of reasons for the removals, for all the reasons held/recorded, including for the reason that the person died.

Trust response:

Q1 and Q2 can be answered by the published RTT data on the NHS England website <u>https://www.england.nhs.uk/statistics/statistical-work-areas/rtt-waiting-times/</u> and is therefore exempt under Section 21 of the Act.

The data is split into financial years on the website and includes the requested years of 2017/18 onwards.

For Q1 please see "Incomplete pathway" data on the website. For Q2 please see completed pathway data under the headings "Admitted pathways" and "Non-admitted pathways"

The following is an excerpt from the website describing the data that is available:

• Incomplete pathways are waiting times for patients waiting to start treatment at the end of the month.

• Admitted pathways are waiting times (time waited) for patients whose treatment started during the month and involved admission to hospital (until September 2015 adjustments were made to admitted pathways for clock pauses, where a patient had declined reasonable offers of admission and chose to wait longer).

• Non-admitted pathways are waiting times (time waited) for patients whose treatment started during the month and did not involve admission to hospital

Q3. Please note: We are able to provide the information starting from April 2020.

The Trust's new RTT system that went live in April 2020 collects the RTT pathway status and therefore can provide the reason that a clock period has been stopped reasonably accurately. The previous RTT system that was used until March 2020 did not collect the same degree of detail.
