## Freedom of Information Act 2000

I am writing in response to your request for information made under the Freedom of Information Act 2000 in relation to high-cost drugs in Ophthalmology and Metabolic diseases.

## You asked:

1 – For the 4 months from May to August 2022, how many patients received the following anti-VEGF treatments for any eye condition:

- a. Aflibercept
- b. Bevacizumab
- c. Brolucizumab
- d. Dexamethasone
- e. Faricimab
- f. Ranibizumab Lucentis
- g. Ranibizumab Ongavia

2 – For the patients above, how many were new to anti-VEGF therapy? Please provide the patient numbers by the treatments listed below, excluding patients who previously had any anti-VEGF therapy.

- a. Aflibercept
- b. Bevacizumab
- c. Brolucizumab
- d. Dexamethasone
- e. Faricimab
- f. Ranibizumab Lucentis
- g. Ranibizumab Ongavia

3 – How many patients have you treated in the last 12 months with the following drugs?

- a. Genotropin
- b. Humatrope
- c. Norditropin
- d. Nutropin

## e. Omnitrope

- f. Saizen
- g. Zomacton
- h. Any other Somatropin (please specify)

## Trust response:

1. Under Section 21 of the Act we are not required to provide information in response to a request if the information is already reasonably accessible to you. The appropriate limit is specified in regulations and represents the estimated cost of one person spending 3½ working days in determining whether the Trust holds the information, locating, retrieving and extracting the information. Under Section 12 of the Freedom of Information Act 2000 the Trust is not obliged to comply with this part of your request and we will not be processing this part of your request further.
